We must unite to fight for Marathi manooos: Uddhav

Shiv Sena (UBT) chief Uddhav Thackeray has said that it is important for him and MNS president Raj Thackeray to come together for the cause of the Marathi language and people.

In the second and final part of his interview with Saamana executive editor and Rajya Sabha MP Sanjay Raut, published in the Sena (UBT) mouthpiece on Sunday, the former chief minister also spoke about alliance politics.

Elections to various local and civic bodies, including the BMC, are likely to be held later this year.

Speaking on the importance of unity among Marathi-speaking people, Shiv Sena (UBT) chief Uddhav Thackeray said he is willing to do anything for the cause of the Marathi language, the “Maharashtra dharma,” and the Marathi manooos (Marathi people).

Responding to speculation about his possible rapprochement with Raj, Uddhav said, “If anyone has an issue with

us coming together, that is their problem.”

When asked about the need for the Marathi manooos to unite on the language issue, he said, “They should come together, because whom are we fighting for? The Marathi manooos.”

Buzz around a potential thaw between the two leaders intensified after they shared the stage at a massive victory rally earlier this month. The rally was held to celebrate the Maharashtra

government's decision to roll back two contentious government resolutions mandating Hindi instruction for students from Classes 1 to 5 under the three-language formula.

Uddhav said now the two cousins can call each other and also meet, and there is no problem in it.

He asserted the Thackerays meet everyone openly.

Asked about the MVA and the alliance in the local body polls, he said, “It's their (Congress) business. There was a discussion with the Congress and they were of the opinion that they will take a decision at the local level. Fair enough. If that is the case, it will happen that way.” Every party has its unit at the civic body level, Uddhav Thackeray noted.

“We will do what the parties (in the MVA) think is politically appropriate for them,” he added.

Uddhav also commented on RSS chief Mohan Bhagwat recently referring to Sangh ideologue late Moropant Pingley's remarks about stepping aside at the age of 75.

Political buzz after Aaditya, CM seen at Sofitel Hotel

A fresh wave of political speculation has emerged in Maharashtra after reports surfaced that Chief Minister Devendra Fadnavis and Shiv Sena (UBT) MLA Aaditya Thackeray were seen at the same hotel in Mumbai on Saturday night. According to sources, both leaders were present at Sofitel Hotel in Mumbai, leading to intense curiosity over possible new political alignments.

Just two days ago, a private meeting between Fadnavis and UBT chief Uddhav Thackeray had raised eyebrows. Now, reports of Aaditya and Fadnavis being at the same venue have further fueled speculation about a potential shift in the state's political equations.

Sources clarified that both

leaders were attending separate events at the hotel and there was no formal meeting between them.

Aaditya Thackeray while speaking to media informed that he had dinner plan along with friends in the hotel. “During the dinner I was watching news of meeting between Chief Minister and I.”

Adding to the intrigue, Fadnavis had recently made a direct political overture to Uddhav, offering him a place in the ruling alliance. “Uddhavji, there is no scope for us to return to the Opposition benches until 2029. But if you wish to join us, the door is open. We can discuss it in a different way,” Fadnavis remarked.

In response, Uddhav Thackeray had said, “Things that happen in the House with friendliness should be taken in the same way”.

‘Faced false FIRs, threats for exposing social evils’

Binu Varghese is a Thane-based activist who has been exposing food adulteration, sex rackets and other social evils. He recently talked to **S Balakrishnan** about his work. Excerpts:

Q. You are a prominent activist of Thane. What prompts you to expose wrongdoings in society? And when did you start your activism?

A. I have been actively involved in social work for the past 23 years. I am a resident of Thane, born and brought up in Mumbai.

Q. How many rackets have you exposed so far?
A. I have successfully exposed and helped bust over 100 rackets.

Q. Which is the biggest racket you have exposed so far? Pl give details.
A. A Rs500-crore hawala racket was busted by me at

Q. An FIR for alleged extortion was filed against you. What happened to that?

A. A false FIR was registered against me after I exposed an assistant TMC commissioner for extorting money from builders. The case was later quashed and I was acquitted by the Hon'ble court after Mahesh Aher himself admitted in court that the FIR was false. Another FIR was filed

naming me as a co-accused alongside former commissioner of police Param Bir Singh. This case, influenced by political interference, was also dismissed by the Hon'ble High Court.

Q. Do you get cooperation from the police and other authorities in your campaign or is there resistance to exposing frauds?

A. Yes, I do receive priority and support in my campaigns when exposing fraud or misconduct, even involving police officers.

Q. Have you received threats from vested interests? If yes, what precautions are you taking?

A. Yes, I have received several threats from underworld elements and political leaders. For my protection, I possess a licensed pistol issued by the Thane commissioner of police 22 years ago.
